

## Capital Group Japan Equity Fund (LUX)

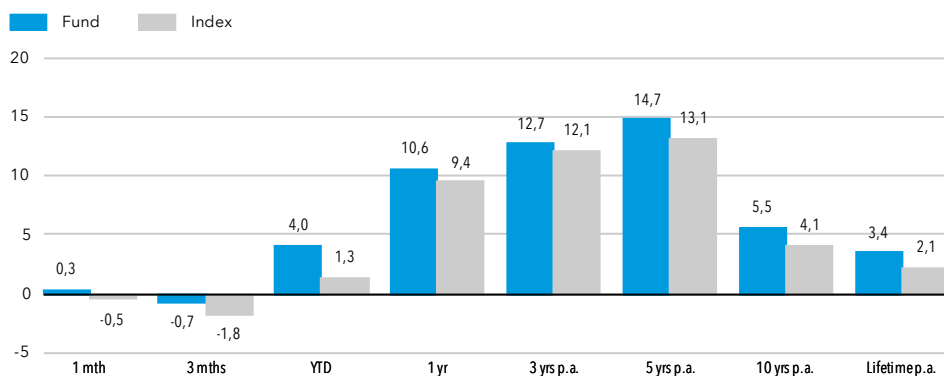
### Objective

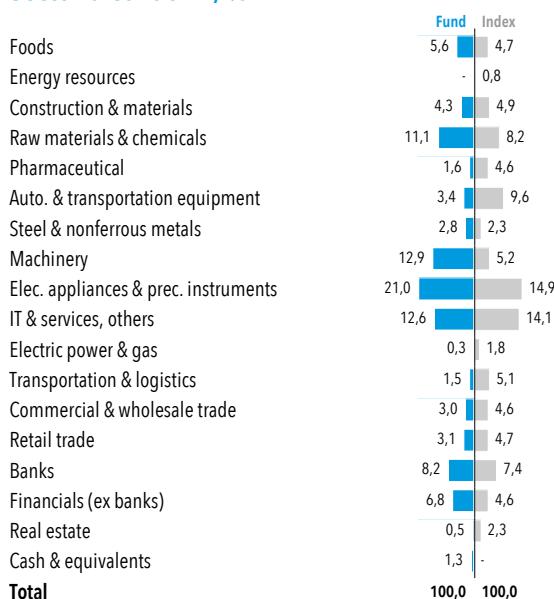
