Objectives & Investment Policy

The aim of the Fund is to achieve capital growth through a long/short strategy, which means investing in shares that the investment manager of the Fund, Ivory Investment Management LLC (Investment Manager) considers will generate returns and taking a short position (or betting against) shares it believes will drop in value, independent of the returns of the market generally. The Fund's primary investment focus is to reflect the return (positive or negative) of shares in publicly listed companies. The Fund may also invest in tradable debt (bonds) and financial instruments (derivatives). The Fund will seek to generate returns primarily from individual share selection as opposed to overall market exposure. Returns are expected to be derived from capital growth (or, in the case of short positions, drops in value) as well as from investment income, such as dividends and other distributions. In addition, the Fund aims to augment and balance

the returns derived from the share selection process by managing exposure to certain macro and systematic risks.

The Fund invests generally in shares in U.S. companies but may invest a portion of its assets globally. The Fund is not limited to any particular industry or sector in pursuing its aim. The Fund may also invest in shares and bonds that are not publicly listed and in shares and bonds that may or may not be rated by credit rating agencies.

Financial contracts (derivatives) may be used for investment purposes and to aim to reduce inflation, interest rate and/or foreign currency exposure in respect of the assets (hedging). Derivatives may also be used to increase returns by increasing the exposure to certain investments (leverage). The leverage is not expected to exceed 400% of the value of the Fund.

No dividends will be paid on your shares.

You may redeem your investment on demand on a weekly basis.

Risk and Reward Profile

The Fund may enter into one or more derivatives with a number of counterparties. If any of the counterparties fail to make payments (for example, it becomes insolvent) this may result in your investment suffering a loss.

Deutsche Bank and its related companies may act in several roles in relation to the Fund such as distributor, counterparty to financial contracts and management company which may involve conflicts of interest.

The Fund is not guaranteed and your investment is at risk. The value of your investment may go down as well as up.

The Fund has been designed for investors who are looking for long term capital growth through exposure to alternative investment strategies. As the Fund may therefore employ sophisticated strategies (including the use of derivatives), it is intended only for knowledgeable and experienced investors who are able to understand and evaluate both the investment strategy and its inherent risks (such understanding and evaluation may be gained through advice from a professional advisor).

The Fund may have increased exposure to particular investments known as leverage. A fall in value of such investments can result in a proportionately greater loss to the Fund.

The Fund relies upon the performance of the Investment Manager and the successful implementation of the strategy. If that investment manager performs poorly or the strategy is not successful, the value of your investment is likely to be adversely affected.

The Fund may use derivatives i) for investment purposes; and ii) to try to reduce exposure to inflation, interest rates and/or movements in currency exchange rates. This may not always be successful and may result in greater fluctuations in the value of the Fund. This may negatively affect the value of the Fund and your investment.

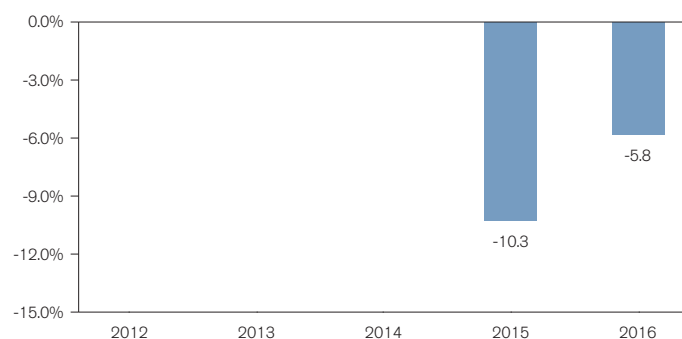


Charges
