# Manulife Asia Pacific Investment Grade Bond Fund

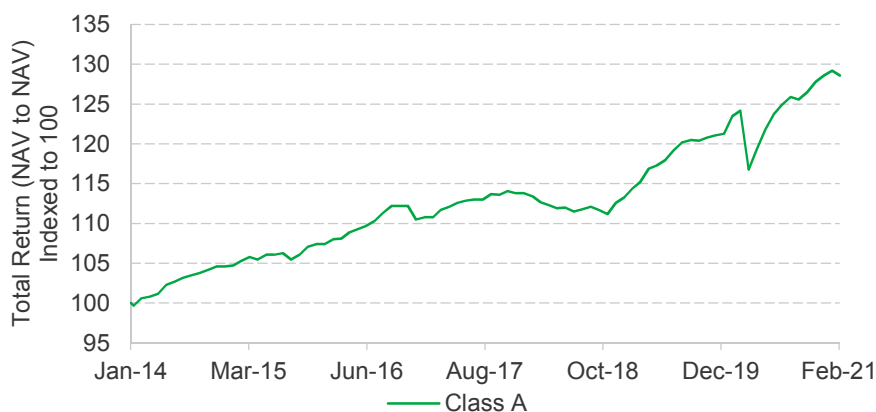
## Investment Objective
