Edmond de Rothschild *Pri*fund Strategy (EUR) invests mainly in money-market instruments, bonds and equity funds with no restrictions on its country or sector weightings. Although otherwise balanced and global, the Fund's allocation strategy features a tilt towards European assets and up to a third of total assets may be comprised of alternative investments. Exposure to these and to equities is managed via constituent funds, the selection of which is based on a thorough process of due diligence including both quantitative and qualitative criteria. The track record of each money manager is carefully analysed, together with the investment strategy he has developed and the structure of his team and management company. Hence, all the ingredients are combined to ensure that the chosen funds' future returns will be among the highest in their respective risk categories.

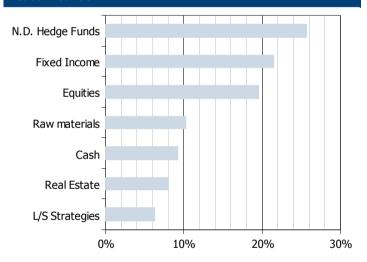

### Asset Breakdown





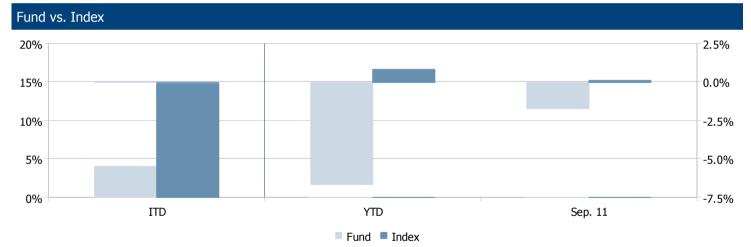
