LionGlobal Short Duration Bond Fund



The investment objective of the Fund is to provide total return of capital growth and income over the medium to long term, through an actively managed portfolio of Singapore and international bonds, high quality interest rate securities and other related securities. There is no target industry or sector. For the avoidance of doubt, while we will generally invest in bonds with investment grade quality, we may nonetheless also invest or expose the Fund to sub-investment grade securities.

Fund Manager's Commentary

- US yields continued to fall on weaker US May payroll numbers, adding to evidence that global economic uncertainty stemming from trade policy is increasing business uncertainty and weighing on growth prospects. European Central Bank's President Draghi was dovish, indicating that they are ready for further stimulus if inflation is not achieved. The weaker data and uncertainties on the trade front have led to Fed fund futures pricing in around 2 cuts for this year.
- The US 10 year yield fell 12 basis points (bps) to 2.00%; yields on the 10 year Singapore Government Securities underperformed, falling by 8 bps to 1.99%. Corporate spreads widened, with JACI IG spreads tightening 6 bps to 190.
- We believe the market has fully priced in rate cuts over the next 2 meetings, thus limiting further drops in yields. Nevertheless, we are still positive on credits as the low interest rate environment has spawned mandates looking for short dated investment grade bonds. We remain invested in credits.




