Objectives and investment strategy

The Fund aims to provide investors with income and medium term capital stability, and invests all or substantially all of its assets in the First State Asian Equity Plus Fund (for equities) (the "Equity Underlying Sub-Fund") and the First State Asian Quality Bond Fund (for fixed income) (the "Bond Underlying Sub-Fund") (collectively the "Underlying Sub-Funds"), under the Dublin registered First State Global Umbrella Fund plc. The Equity Underlying Sub-Fund invests primarily (at least 70% of its net asset value) in equity securities or equity-related securities of companies that are listed, or have their registered offices in, or conduct a majority of their economic activity in the Asia Pacific region (excluding Japan). The Bond Underlying Sub-Fund invests primarily (at least 70% of its net asset value) in debt securities of governments or quasi-government organisation issuers in Asia and/or issuers organised, headquartered or having their primary business operations in Asia.

The CPF interest rate for the Ordinary Account (OA) is based on the 12-month fixed deposit and month-end savings rates of the major local banks. Under the CPF Act, the Board pays a minimum interest of 2.5% per annum when this interest formula yields a lower rate. The government will maintain the 4% per annum minimum rate for interest earned on all Special and Medisave Accounts (SMA) and Retirement Account (RA) monies until 31 December 2019, subject to updates from the CPF board. The CPF Board will pay an extra interest rate of 1% per annum on the first \$\$60,000 of a CPF member's combined balances, including up to \$\$20,000 in the OA. In addition, CPF members aged 55 and above will also earn an additional 1% extra interest on the first \$30,000 of their combined balances (with up to \$20,000 from the OA). Only monies in excess of \$\$20,000 in the OA and \$\$40,000 in the Special Account can be invested.
