Objectives and Investment Policy

Investment Objective: The Sub-Fund seeks to achieve a return in the Reference Currency in line with prevailing money market rates whilst aiming to preserve capital consistent with such rates and to maintain a high degree of liquidity by investing in EUR denominated short term debt securities.

Investment Policy: The Sub-Fund will invest all of its assets, excluding cash and cash equivalents, in EUR denominated short term debt securities.

The Sub-Fund may have exposure to investments with zero or negative yields in adverse market conditions.

Debt securities with a long-term rating will be rated at least A and debt securities with a short-term rating will be rated at least A-1 by Standard & Poor's or otherwise similarly rated by another independent rating agency.

The Sub-Fund may also invest in unrated debt securities of comparable credit quality to those specified above.

The weighted average maturity of the Sub-Fund's investments will not exceed 60 days and the initial or remaining maturity of each

debt security will not exceed 12 months at the time of purchase (for government and public securities the maturity will not exceed 397 days).

The Sub-Fund may use financial derivative instruments for the purposes of hedging and efficient portfolio management.

This Sub-Fund qualifies as a "Short-Term Money Market Fund" in accordance with ESMA (previously CESR) guidelines reference CESR/10-049.

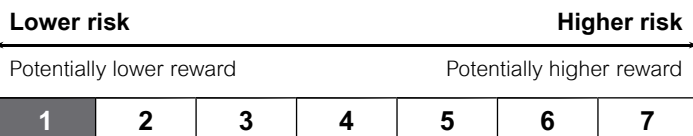
Redemption and Dealing: Shares of the Sub-Fund may be redeemed on demand, with dealing normally on a daily basis.

Management Discretion: The Investment Manager has the discretion to buy and sell investments on behalf of the Sub-Fund within the limits of the Objective and Investment Policy.

Distribution Policy: This Share Class will not pay dividends.

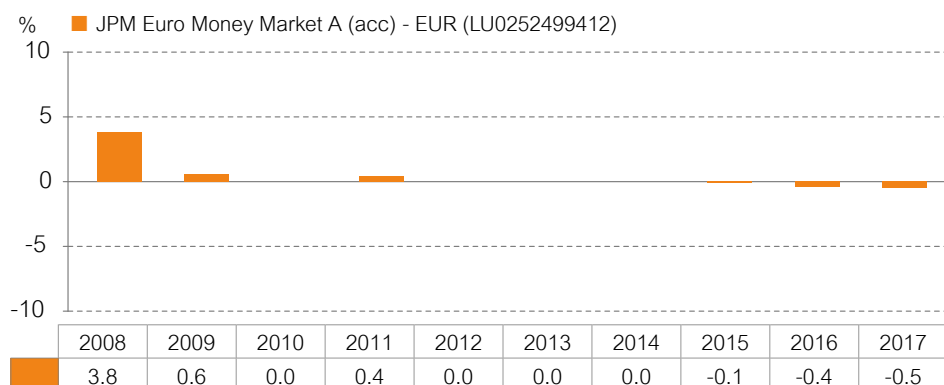
