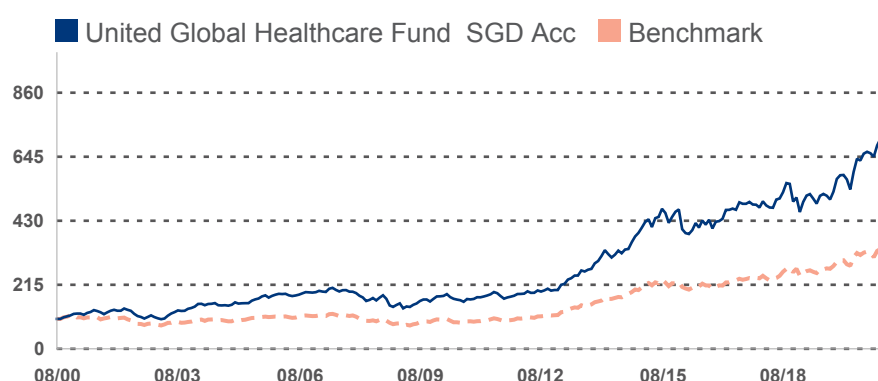


United Global Healthcare Fund

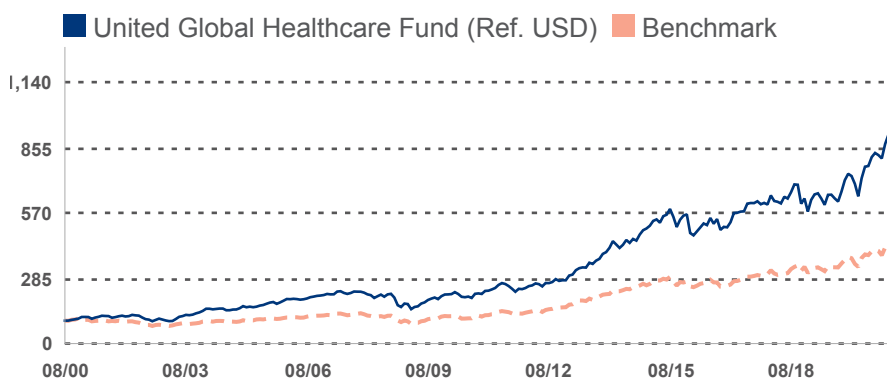

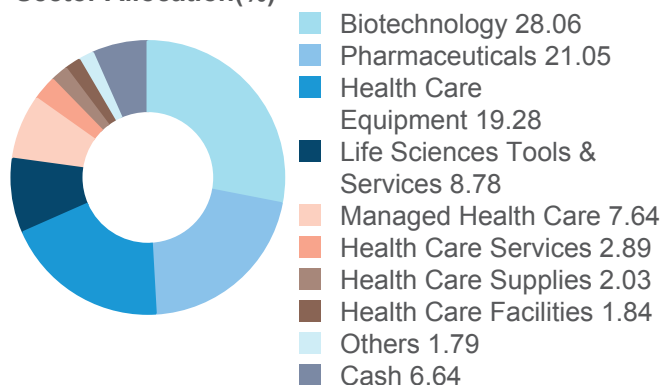

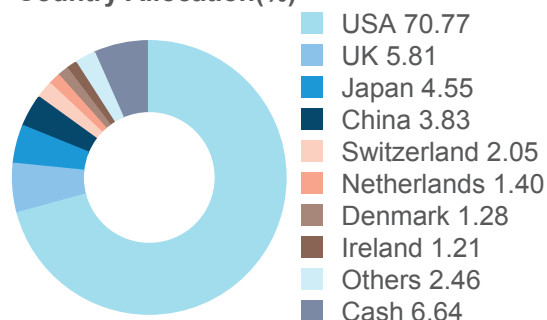
