Fund aim

The Fund aims to provide capital growth by investing at least 80% of its net assets in equities or equity-related securities of companies with either their registered office in China or Hong Kong, or which do most of their business in China or Hong Kong.

The Fund takes long positions on shares it believes are promising (meaning that the Fund will gain to the extent these share prices rise) and takes short positions in shares it believes are likely to decline in price (meaning the Fund will gain to the extent these share prices fall). The Fund will have significantly greater exposure to long positions and is therefore likely to demonstrate a high correlation to Chinese equity markets in general.

The Fund may use derivatives to achieve the Fund's investment objective, to reduce risk or to manage the Fund more efficiently.

As of 6 February 2015, Charlie Awdry took over management of this fund from Caroline Maurer.

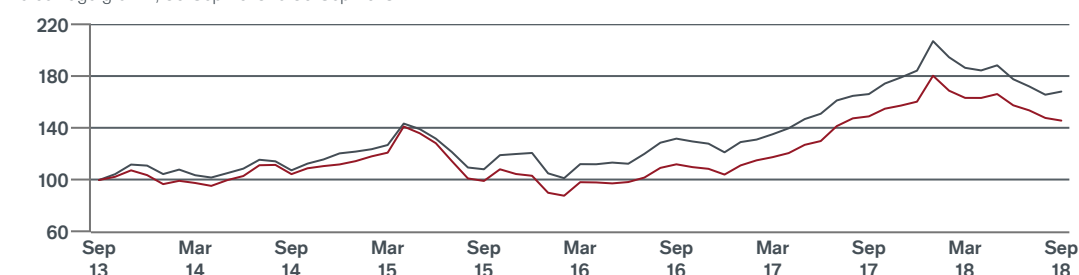
