### Objectives and Investment Policy


The Fund seeks to increase the value of its assets over the medium term by investing in shares issued by Russian companies, and/or companies operating in this country.

It is actively managed and as such may invest in securities that are not included in the index which is MSCI Russia 10/40 (NR).

Income are systematically reinvested.

Investors are able to redeem on a daily basis (on Luxembourg bank business days) unless the London and/or Moscow Stock Exchange are closed.

#### Risk and Reward Profile

- <u>Liquidity Risk:</u> This risk arises from the difficulty of selling an asset at a fair market price and at a desired time due to lack of buyers.
- <u>Operational and Custody Risk</u>: Some markets are less regulated than most of the international markets; hence, the services related to custody and liquidation for the subfund on such markets could be more risky.
