### FUND OVERVIEW

The investment strategy of the Fund is deemed by the Directors of the Fund to be capacity constrained. Shares in the Fund are not available to buy until further notice except at the discretion of the Directors of the Fund (you can still sell your Shares daily). The Fund aims to maximise the return on your investment through a combination of capital growth and income on the Fund's assets and invest in a manner consistent with the principles of environmental, social and governance (ESG) investing. The Fund invests at least 70% of its total assets in the equity securities (e.g. shares) of small and mid capitalisation companies domiciled in, or the main business of which is in, Switzerland.
