Objectives and Investment Policy

The Fund belongs to the category of funds of funds. It seeks to increase the value of its assets over the medium term by implementing a flexible and diversified prudent, deemed stable, allocation strategy on all types of asset classes, investing through funds in these limits (equities: 0%-30%, fixed income: 35%-85%, alternatives (see full prospectus definition): 0%-40%, cash: 0%-25%). However, when such investment is not considered appropriate, the Fund may invest directly in underlying assets. Emphasis is placed on international diversification of investments. It is actively managed and as such may invest in securities that are not included in the composite index weighted as follows: 15% MSCI World AC + 5% MSCI EMU + 70% Barclays EuroAggregate + 10% Eonia.

Income are systematically reinvested.

Investors are able to redeem on a daily basis (on Luxembourg bank business days).

- Why is the Fund in this specific category?
The risk category is justified by the investment in different asset classes with a standard asset mix that is a low proportion of risky assets and a high proportion of less risky assets.
- The higher the risk, the longer the recommended investment horizon.

Other risks materially relevant to the Fund which are not adequately captured by the indicator are described below:

- **Credit Risk:** This risk relates to the ability of an issuer to honour its commitments: downgrades of an issue or issuer rating may lead to a drop in the value of associated bonds.
- **Liquidity Risk:** This risk arises from the difficulty of selling an asset at a fair market price and at a desired time due to lack of buyers.
- **Counterparty Risk:** This risk is associated with the ability of a counterparty in an Over The Counter financial transaction to fulfil its commitments like payment, delivery and reimbursement.
- **Derivatives Risk:** When investing in over the counter or listed derivatives, the Fund aims to hedge and/or to leverage the yield of its position. The attention of the investor is drawn to the fact that leverage increases the volatility of the subfund.

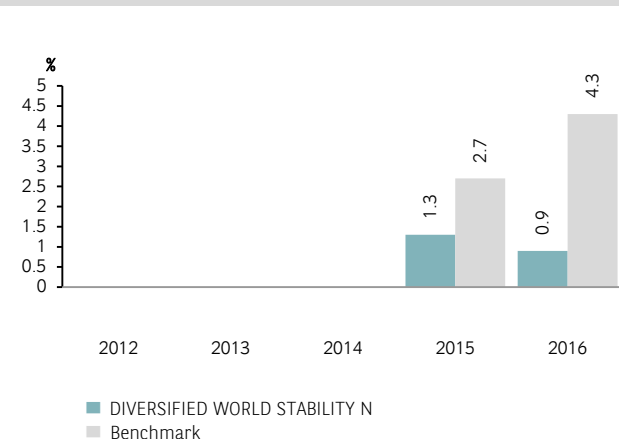
This figure may vary from year to year. It excludes:
