Legal notice

The software used performs calculations on the basis of more than the two decimal places displayed. Minor discrepancies cannot be ruled out due to further calculations using published results.

The value of a unit is calculated by dividing the entire value of the investment fund inclusive of its income by the number of units. The total value of the investment fund is calculated on the basis of the current market prices of the securities, money market instruments and subscription rights in the fund plus the value of the fund's financial investments, cash holdings, credit balances, receivables and other rights net of its payables. That value will be calculated by the custodian bank.

The net assets are calculated in accordance with the following principles:

- a) The value of assets quoted or traded on a stock exchange or other regulated market shall be determined, in principle, on the basis of the most recently available price.
- b) Where an asset is not quoted or traded on a stock market or another regulated market or where the price for an asset quoted or traded on a stock market or another regulated market does not appropriately reflect its actual market value, the prices provided by reliable data providers or, alternatively, market prices for equivalent securities or other recognized market valuation methods shall be used.

Raiffeisen KAG uses the method developed by OeKB (Österreichische Kontrollbank AG) to calculate the fund's performance, on the basis of data provided by the custodian bank (where payment of the redemption price is suspended, using indicative values). Some costs – the subscription fee (not exceeding 4.00 % of the invested amount) and any redemption fee (not exceeding 0.00 % of the sold amount) – are not included in the performance calculation. Depending on their concrete value, they will reduce a performance accordingly. Past results do not permit any reliable inferences as to the future performance of the fund.

Fund investment policy report

In H1 2020, the capital markets were defined by the global coronavirus crisis. While only China was affected at the start of the year, the virus outbreak rapidly turned into a pandemic. Global containment measures resulted in an economic downturn that exceeded the 2009 financial crisis in terms of both speed and depth. Until March 2020, the markets were in freefall. All of the central banks, first and foremost in the USA but also to a significant degree in the EU and China, implemented massive support programs coupled with strong fiscal impulses. Market dynamics changed as of late March 2020, with emerging markets recovering around half of the losses by June 2020.

This trend came to a halt in summer when the weak US dollar failed to support the emerging markets to the usual extent from June 2020 onwards since its weakness was not accompanied by improved prospects for the emerging markets. In regional terms, the negative impact was most substantial in Latin America and South Africa, not only due to high local infection rates but also to the countries' sensitivity to global economic trends. Brazil and South Africa, in particular, raised government spending despite their high debt levels. Turkey came under pressure due to low reserves. Russia and Indonesia were also substantially weaker. By contrast, the Central European countries (ex Hungary) gained thanks to EU corona relief funds. Owing to weaker prospects for China, the fund still had a defensive positioning at the beginning of the year via a high cash quota, some currency hedging and a reduction of the interest rate sensitivity. This positioning cushioned the negative performance during the turbulent phase until late March 2020. The currency hedge was neutralized at the end of April 2020 and the fund was fully invested from late May to mid-June 2020; around half of the negative performance had been recovered by July 2020. As of the middle of June 2020, the positioning became more defensive again. All in all, the overlay strategies made a positive contribution which, however, did not compensate for the absolute performance of the country allocation, which was altogether significantly negative. At present, the markets are focusing on the USA: the election campaign, relations with China and expectations of a new fiscal package. The renewed rise in infection rates is also moving to the forefront: the hope that the worst is over could be challenged by a second wave of infection in Europe in the fall.

In accordance with the requirements stipulated in the Regulation (EU) No. 648/2012 of the European Parliament and of the Council on OTC derivatives, central counterparties and trade repositories ("EMIR"), OTC derivatives are collateralized except for a minimum transfer amount, thus reducing the risk of default for the OTC derivative counterparty. Only sight deposits paid into an account kept by a credit institution which is independent of the counterparty were used as collateral during the reporting period. Haircuts are not taken into consideration here. Sight deposits received as collateral are not used to purchase further assets for the fund assets or otherwise reused.

On July 31, 2020, only OTC derivatives (forward exchange transactions) were open. Raiffeisen Bank International AG was the counterparty and had deposited 140,000.00 EUR on an account kept by State Street Bank GmbH by way of collateral.

Total return swaps and similar derivative instruments

A total return swap is a credit derivative instrument. Income and fluctuations in the value of the underlying financial instrument (underlying instrument or reference asset) are exchanged for fixed interest payments.

The fund did not enter into total return swaps or similar derivative instruments in the period under review.
