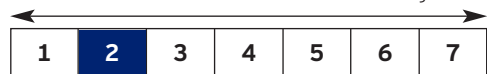

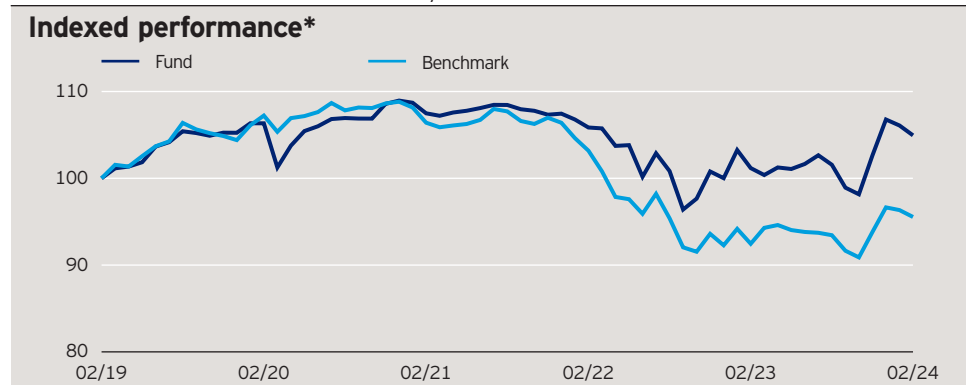

Fund Strategy

The fund's largest allocation is to developed market government bonds. This exposure currently includes an allocation to US Treasury Inflation Protected Securities. To benefit from the additional yield available, the fund also has exposure to corporate bonds as well as some exposure to emerging market bonds.

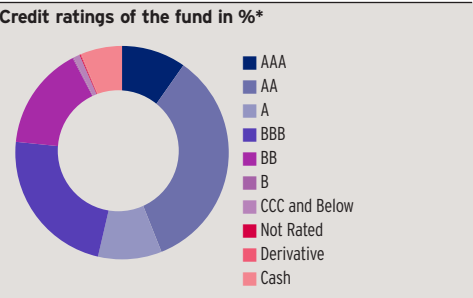

The wording of international sanctions is something that we pay particular attention to as there are occasions where sanctions can exist in limited form, for example allowing investments in the secondary market. In addition to sanctions targeting entire countries, there are other thematic regimes, which may focus for example on human rights, cyber attacks, terrorist financing and corruption, which may apply to both individuals and/or entities/corporations.
