## Objectives and Investment Policy

The Fund's objective is to produce returns, net of fees and expenses above the Bloomberg Barclays Global Corporate Custom Weighted Index (index ID 33681), an index constructed by Bloomberg Barclays comprised of 67% of the Bloomberg Barclays Global Aggregate Corporate Total Return Index Value Hedged USD and 33% of the Bloomberg Barclays Global High Yield Corporate Total Return Index Value Hedged USD.

Different share classes may have different currency denominations for hedging purposes. See the Prospectus and Fund Supplement for further details.

The Fund will have a net-long, long/short strategy meaning it will take positions in assets which are deemed undervalued (long) and assets which are deemed overvalued (short).

The Fund will invest in a diversified portfolio of fixed income instruments. This includes corporate bonds of companies worldwide, government securities and futures and other debt instruments of varying duration issued by firms with equity traded on recognised exchanges. At least half of such instruments will be rated investment grade.

The Fund will also buy and sell protection in credit default swaps (CDS). CDS are contracts which allow the transfer of credit risk from one party to the other. The CDS will have underlying exposure to the

credit risk of companies worldwide. The Fund is expected to have long exposures of 150% to 300% and short exposures of 50% to 200% of the Net Asset Value of the Fund. The Fund may have a maximum level of leverage up to 900% of the Net Asset Value of the Fund when derivatives used for hedging purposes are taken into account.

The Fund can also invest in cash deposits.

The Fund may hold both USD and non-USD denominated fixed income instruments and currency positions.

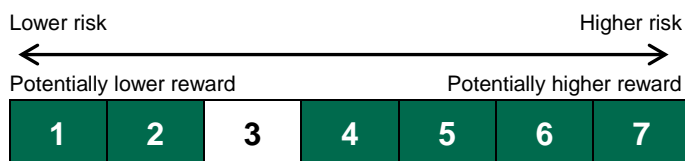
Derivatives such as CDS, interest rate swaps, total return swaps, FX forwards and futures are used to take positions for investment or for hedging purposes. For full investment objectives and policy detail, please refer to the Prospectus and Fund Supplement.

Class A USD Accumulating does not pay a dividend. Any income arising is retained in the Fund and reflected in the value of the share class.

Shares can be bought from and sold back to the Fund on any banking business day in Ireland when the Federal Reserve Bank in the US and the New York Stock Exchange are also open for business.

The Fund has a level 3 risk and reward profile because it is invested in a diversified portfolio of fixed income instruments with moderate interest rate risk.

The Fund invests in complex derivatives which may multiply the exposure to underlying assets.

## Charges

The charges you pay are used to pay the costs of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

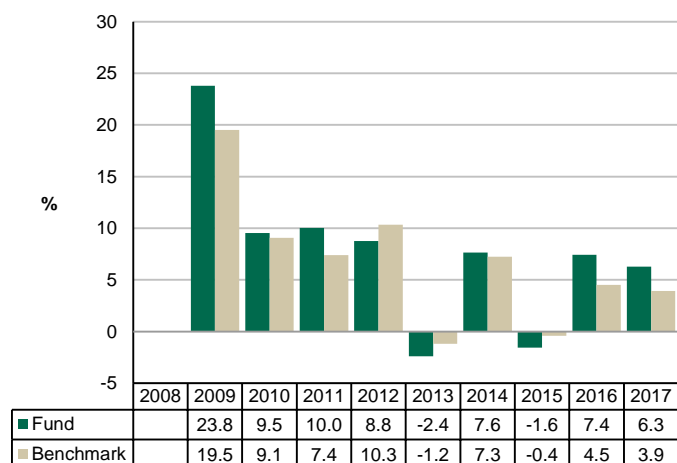

The Fund will charge an anti-dilution levy where on any day there are net redemption or subscription requests. The anti-dilution levy will be applied to the dealing price of the shares being redeemed or subscribed by the relevant shareholder(s) on that day and shall not exceed 0.50%. The proceeds of the anti-dilution levy are retained with the Fund with the aim of ensuring that transaction costs related to subscription and redemption activity are borne by the transacting investor and do not negatively impact existing investors.
