Objectives and Investment Policy

Investment Objective: The Sub-Fund aims to provide long-term capital growth by investing primarily in companies in the Asia Pacific Basin (excluding Japan).

The term "Pacific Basin" refers to an area including Australia, Hong Kong, New Zealand, Singapore, China, Indonesia, Korea, Malaysia, the Philippines, Taiwan, Thailand and the Indian subcontinent, excluding the United States of America, Central and South America.

Investment Policy: At least 67% of the Sub-Fund's assets (excluding cash and cash equivalents) will be invested in equity securities of companies (including smaller capitalisation companies) that are domiciled in, or carrying out the main part of their economic activity in, an Asia Pacific Basin country (excluding Japan).

Certain countries in the Asia Pacific Basin may be considered emerging market countries.

The Sub-Fund uses an investment process that is based on systematic investments in equity securities with specific style characteristics, such as value, momentum in price and earnings trends. Historical research has demonstrated that such securities can outperform over a market cycle as they exploit psychological factors (the behavioural and cognitive biases of investors) in stock markets. For example, investor overconfidence, the expectation that a security's earnings will continue to grow in perpetuity, or loss

aversion, the reluctance of an investor to sell a security that is decreasing in price.

The Sub-Fund may invest in China A-Shares via the China-Hong Kong Stock Connect Programmes.

The Sub-Fund may invest in assets denominated in any currency although currency exposure will not generally be hedged.

The Sub-Fund may use financial derivative instruments for the purposes of hedging and efficient portfolio management.

Redemption and Dealing: Shares of the Sub-Fund may be redeemed on demand, with dealing normally on a daily basis.

Management Discretion: The Investment Manager has the discretion to buy and sell investments on behalf of the Sub-Fund within the limits of the Objective and Investment Policy.

Benchmark: The benchmark of the Share Class is MSCI All Country Asia Pacific ex Japan Index (Total Return Net).

The benchmark is a point of reference against which the performance of the Share Class may be measured. The portfolio of the Sub-Fund will bear some resemblance to its benchmark.

Distribution Policy: This Share Class will not pay dividends.


