Objectives and Investment Policy

The aim is to achieve an ongoing source of income with potential to increase the value of your investment by investing in other investment funds.

The Fund is known as a "fund of funds" which means that it invests mainly in other investment funds, as opposed to investing directly in shares or tradable debt. These underlying funds may include funds traded on major stock exchanges (known as exchange traded funds) and will normally provide exposure to different asset types across various markets in a 'passive' manner, i.e. without active stock selection. The Fund may also invest directly in government and corporate bonds and other transferable securities which will normally be listed or traded on regulated markets in Europe, the US and Japan or other regulated markets.




Charges
