Performance Review

August witnessed a resumption of the sell-off in risk assets as the July rise turned out to be a blip. Global equities edged up during the month, riding on the strength of US equities that turned out to be a rare comfort zone for investors. Even the Developed Markets (DM) outside US failed to provide respite to investors with Europe and Australia falling, while Japan stayed flat. US sanctions, trade tariffs and risk of contagion in Emerging Markets (EM) occupied the headlines, souring investor sentiment. EMs fell in August, thanks to a sharp fall in a basket of EM currencies given widening credit spreads. Barring the Thai Baht and the Korean Won, all other EM currencies were flat to down, with six of them falling in excess of 5% during the month – the Turkish Lira, South African Rand, Russian Ruble, Brazilian Real, Chilean Peso and Colombian Peso. Energy prices picked up in August (Brent Crude, Natural Gas), precious metals (Gold, Silver, Platinum) and soft commodities mostly fell, while industrial metals were mixed like Aluminum and Copper. Healthcare was the only sector in EM to advance in August, with Utilities being the worst performing sector.

Performance Attribution

The fund was up this month comparing with the wider market. Positive Selection in Utilities, Information Technology, Telecoms, and Consumer Discretionary was supported by positive Allocation in Industrials. On a single stock level, among the best performers were TSMC, ITC, Guangdong Investment, Uni-President Enterprises, and Techtronic Industries. Laggards were Thai Beverage, TCS Group, and KT&G.

Current Positioning

The fund focuses on high dividend-yield and high dividend-growth companies with moderate pay-out ratios, strong balance sheets and cash flow, stable or expanding business model, and strong management. From a sector perspective, our biggest underweights are in Cyclicals (e.g. Information Technology and Industrials). Our largest overweights are in Defensives (e.g. Consumer Staples, Telecoms, and Utilities). On a country level, we are overweight in Taiwan and the Czech Republic. Our biggest underweights are in China, India and South Korea.

Outlook

We expect Gross Domestic Product (GDP) growth in Emerging Markets to maintain a superior growth rate relative to Developed Markets, albeit at a slower pace than in the past. Downside risks remain in the form of potential setbacks in the European fiscal situation, US government fiscal and interest rate decisions, US sanctions, trade tariffs, and risk of contagion in Emerging Markets as well as a slowdown in China's economy. If cyclical improvement unfolds, we believe Emerging Markets could be major beneficiaries in a recurring risk-on environment on the basis of capital inflows and comparatively attractive valuations. Fund management continues to actively seek attractive investment opportunities.

Glossary



Alpha

A measure of the difference between the risk-adjusted return on an investment and a benchmark. The alpha measures the part of the performance that cannot be explained by market movements or market risk, but rather is derived from the selection of securities within the market. Alpha is a way of measuring the active contribution to performance made by the portfolio manager. It is also a good yardstick to use when comparing several funds. The figure is calculated on a 3-yearly basis.

Average dividend vield

Measures the average dividend amount, based on the current share price. This figure is calculated based on the shares (including ADRs/GDRs - > Depositary receipts) and REITs contained in a fund.

Average market capitalization

Measures the average market capitalization of the shares, REITs and ADRs/GDRs (depositary receipts) contained in a fund. The market capitalization represents the total market value of a company as determined by multiplying the number of shares issued by the current share price.

Beta factor

A measure of sensitivity - given as the average percentage change in the price of a fund when the market (benchmark) rises or falls by 1%. A value over (under) 1 means that on average the fund exhibits more (less) volatility than the benchmark. The figure is calculated on a 3-yearly basis.

Correlation coefficient

Describes the degree to which two values (fund versus benchmark) move in the same direction. The value of the correlation coefficient is between -1 and +1. A correlation of +1 means that the fund generally moves in the same direction as the benchmark, while -1 indicates that the fund generally moves in the opposite direction. A correlation of 0 means that there is no relation between the price movements of the fund and the benchmark. The figure is calculated on a 3-yearly basis.

Current interest yield

The current interest yield differs from the nominal interest rate because securities are bought at a price that can be higher or lower than their nominal value. Since interest is always paid on the nominal value, the following calculation is used: (interest rate x 100)/price = effective yield.

Duration (in years/in months)

A measure of the sensitivity of an investment to changes in interest rates. Duration, which was developed by Frederick Macaulay, is the average period for which invested capital is committed. Because of the interest payable over time on the invested capital, duration is shorter than -> maturity. This version of duration is used in DWS Top Reporting and refers to invested assets (without "Cash and other holdings").

Information ratio

The information ratio measures the difference between the annualized average return of the fund and that of the benchmark, divided by the Tracking error. The higher this value is, the more the investor pays for the risk in the fund. The figure is calculated on a 3-yearly basis.

Maturity (in years/in months)

The amount of time until the maturity of an obligation, such as a bond. Refers to invested fund assets (without "Cash and other holdings").

Maximum drawdown

The maximum drawdown is the largest percentage drop in value in a given period of time. It measures the amount the fund falls from its highest point to its lowest point in the selected timeframe. The figure is calculated on a 3-yearly basis.

Modified duration (in years/in months)

Serves as a measure of interest-rate sensitivity. Modified duration indicates the percentage change in price of a bond (in a portfolio) when the market interest rate changes by 1%. In order to calculate the percentage change in the bond price, the modified duration of the bond is multiplied by the percentage change in the interest rate. This figure helps investors assess the risks and opportunities of a bond at a glance.

Sharpe ratio

A measure of risk developed by William F. Sharpe, defined as the excess return on an investment over that of a risk-free investment in relation to the risk of the investment. The higher the Sharpe ratio, the higher the yield the investor receives for the risk the investment carries (expressed in volatility). The Sharpe ratio can be used to compare multiple funds. The figure is calculated on a 3-yearly basis.

Tracking error

The tracking error is the standard deviation of the yield differential between a fund and its benchmark. This makes it a measure of how well the fund manager tracks the benchmark. The figure is calculated on a 3-yearly basis.

VaR (Value at Risk)

A measure of risk that indicates the maximum fund losses with a given probability for a given period of time (holding period). VaR is calculated on the basis of the daily prices of the individual securities contained in the portfolio for a year.

Yield

The yield is the annual return on a capital investment, measured as the actual interest earned (effective yield) on the capital invested. It is based on the fund's income (e.g., interest, dividends, realized capital gains) and change in the price of the assets held in the fund. The yield of a fund is

derived from the invested assets (without "Cash and other holdings") and is presented as a "gross" figure, i.e., before the deduction of total expenses/fee.

Volatility

Volatility expresses the degree to which the yield on an investment (the price performance of a fund, for example) varies from a mean value in a specific period of time. This makes it a measure of fund risk. The greater the variation from the mean, the higher the volatility. Knowing the volatility allows investors to assess the profit and loss potential of an investment. The figure is calculated on a 3-yearly basis.
