

Summary of fund objective

The investment objective of the Fund is to seek long term capital appreciation, measured in Yen, through investment primarily in the equity securities of companies domiciled in or exercising the predominant part of their economic activity in Japan and which are listed on any exchanges or over the counter markets. The Fund will invest in companies who make advantageous use not only of their capital but also of their intangible assets (for example, but not limited to, brand values, technical development or strong customer base). The Fund may also invest, on an ancillary basis, in debt securities convertible into common shares and other equity linked instruments. On 9 August 2024, a Luxembourg domiciled SICAV named Invesco Responsible Japanese Equity Value Discovery Fund was merged into the Invesco Japanese Equity Advantage Fund, a sub-fund within the same fund umbrella.



The effective use of intangibles can generate strong free cash flow and increase enterprise value.

Past performance does not predict future returns. The performance period shown here starts on the last day of the first indicated month and ends on the last day of the last indicated month.




