Fund Description

The CommoditiesPLUS Strategy Fund offers exposure to the Dow Jones-UBS Commodity Index primarily via commodity-linked derivatives. These are collateralised by a diversified portfolio of short-duration, investment grade fixed income securities, denominated in major world currencies. Average portfolio duration will normally vary by one to three years.

Investor Benefits

This fund offers portfolio diversification, an inflation hedge, and exposure to the returns of both commodity markets and global bond markets.

The Fund Advantage

The fund captures the total return of the index and seeks to enhance performance by exploiting structural inefficiencies in the commodity market.

Risk Profile

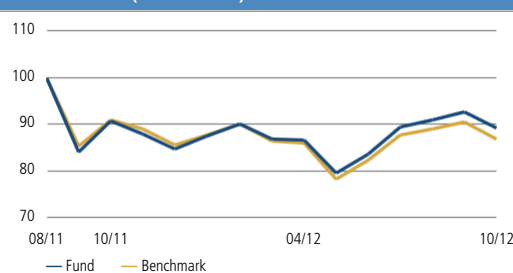

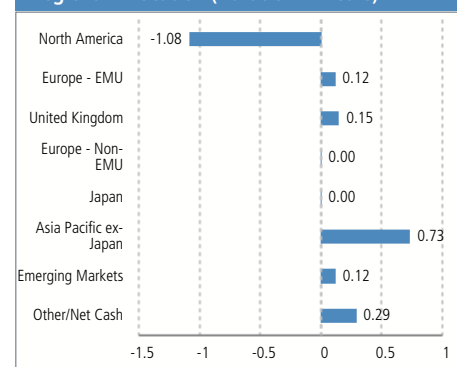

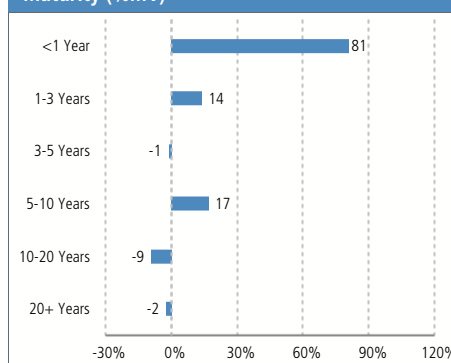

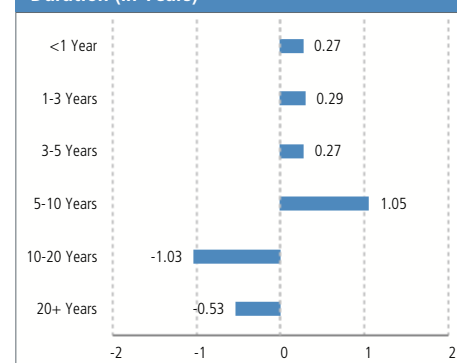
Regional Allocation (Duration in Years)



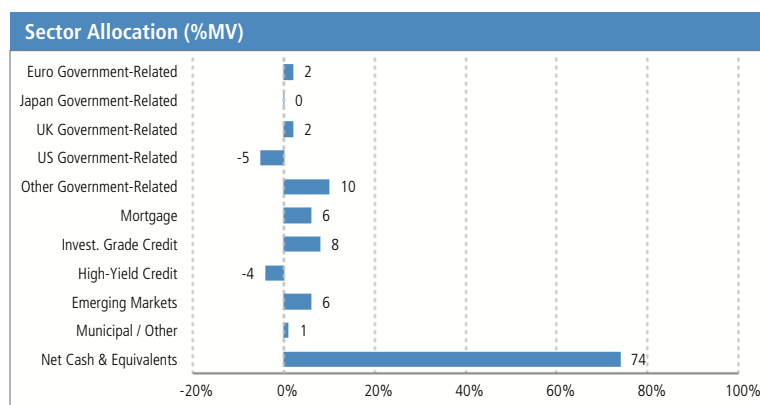
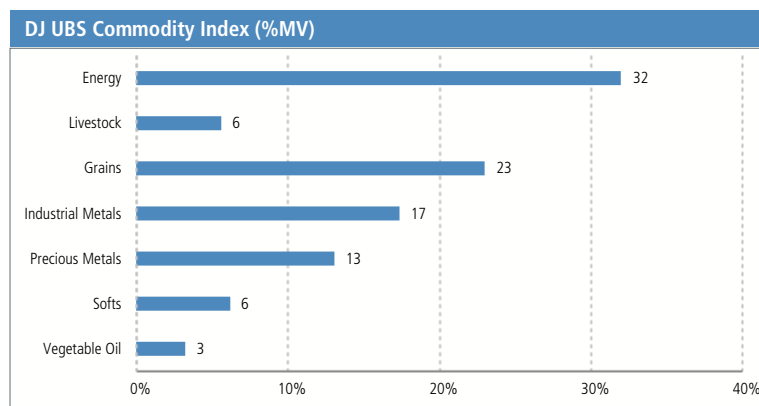
Maturity (%MV)
