Lazard Global Listed Infrastructure Equity Fund is a sub-fund of Lazard Global Active Funds Public Limited Company (the "UCITS")

Objectives and Investment Policy

Lazard Global Listed Infrastructure Equity Fund (the "Fund") aims to achieve over the longterm total returns comprising income and capital growth.

The Fund will seek to achieve its investment objective primarily through investment on a global basis in equities (i.e. shares) and equity-related instruments of Infrastructure Companies

In identifying the Infrastructure Companies in which the Fund will invest, the Investment Manager applies a series of objective filters and gualitative criteria to the general investment universe of infrastructure companies to produce a "preferred list". The shares of the "preferred list" are then individually assessed and ranked, using fundamental analysis (such as selecting infrastructure companies that have good management structures and attractive financial data).

The Fund may invest up to 10% of its value in units or shares of other investment funds (including exchange traded funds and other sub-funds of the Company). In addition, the Fund may invest on a global basis in Convertible Securities (which are investments that are convertible into equity securities of the issuer), and in units or shares of closed ended listed funds

In order to ensure full flexibility to seek exposure to Infrastructure Companies on a worldwide basis, in excess of 20% of the value of the Fund may be invested in emerging markets. Investment in securities listed or traded in Russia shall not exceed 5% of the Fund's value at any time and shall be limited to securities which are listed or traded on the Moscow Exchange

The Investment Manager at all times retains the flexibility to allocate a portion of the Fund's value to cash or cash equivalent securities where satisfied that it is in the best interests of the Fund to do so

Risk and Reward Profile



The risk and reward categories above are calculated using historic data and may not be a reliable indicator of the Fund's future risk profile. The risk and reward category may shift over time and is not a target or guarantee. The lowest category (i.e. category 1) does not mean "risk free"

The risk rating of this Share Class is calculated on the basis of historic volatility - i.e. how much the value of the underlying assets of the Fund has fluctuated over the last 5 years. This Share Class has been placed in the risk category stated above, because based on the historic data, the underlying assets within the Fund have shown moderately high volatility.

Please note, there are other risks that may not be reflected in the risk and reward categories above. Some of these risks are summarised below

- There is no capital guarantee or protection of the value of the Fund. The value of your investment and the income from it can go down as well as up and you may not get back the amount you invested.
- Since the Fund invests on a global basis in Infrastructure Companies, it may be less diversified than other funds investing in a broader range of industries. Securities and instruments of Infrastructure Companies may be more susceptible to adverse

The Fund may use derivatives (which are financial contracts whose value is linked to the price of an underlying investment). As a result of its use of derivatives, the Fund may be 'geared' or 'leveraged' (which can lead to a proportionately much larger movement in the value of the Fund's assets). The expected levels of the Fund's leverage will be 40% of the value of the Fund

The currency exposures of the Fund's portfolio will be substantially hedged back into Sterling, being the base currency of the Fund. However, the Fund's total foreign currency exposure may not be fully hedged at all times.

You can buy or sell shares in the Fund on any day on which the stock exchanges in London, New York and Sydney are open for business.

The Fund has discretion as to which investments it will hold within the limits of the Investment Objective and Policy.

Any distributions that are paid to you will normally be reinvested to buy further shares unless you have elected to receive payment in cash

The Fund's performance is measured against the performance of the FTSE Developed Core Infrastructure 50/50 Index to 30th June 2018. From 1st July 2018, the Fund's performance is measured against the MSCI World Core Infrastructure Index (the "Benchmark Index"). However, the Fund has flexibility to invest in securities and asset classes not included in the Benchmark.

Recommendation: This Fund may not be appropriate for investors who plan to withdraw their money within a short period of time.


