Objectives and Investment Policy

The aim is to increase the value of your investment over the long-term by investing primarily in companies based in emerging market countries.

The Fund is actively managed and invests in shares and convertible securities (tradable debt which can be converted into shares) issued by companies, across a range of industries, based in and traded on stock exchanges in emerging market countries.

The investment manager has discretion to select the companies it chooses to invest in but does take into consideration the universe of companies represented by the MSCI Emerging Markets Index (Net Return).

While the Index may inform the selection of potential investments, the overall Fund investments, as well as the performance of the Fund, can differ significantly from the Index.


The Fund may use financial contracts (derivatives) to help achieve its aim and to manage risk, reduce costs and improve results.




Charges
