## **Objectives & Investment Policy**

The aim is to increase the value of your investment and to earn income within the Fund.

The Fund is actively managed and invests mainly in multicurrency tradable debt (such as bonds or notes), money market instruments (a range of short-term financial products which can be easily bought and sold on money markets) preferred shares and convertible securities (tradable debt which can be converted into shares) with an average outstanding repayment term of less than 3 years, issued by companies, governments and public bodies worldwide.

When selecting investments, the Fund will focus on the risk of default (known as credit risk) on the part of the issuer of the debt and will select debt which is considered "investment grade" (rated BBB- / Baa3 or higher by the major rating agencies).

The Fund may purchase tradable debt in currencies other than the base currency of the Fund and, where it does so, may decide to use financial contracts (derivatives) to manage its exposure to these currencies.


The Fund may also use derivatives to help achieve its aim and to manage risk, reduce costs and improve results.

Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

Income is paid out quarterly.

You may sell your investment on a daily basis.

#### Risk and Reward Profile

may be that the use of derivatives causes share prices to fluctuate which may in turn result in loss to the Fund.


