Objectives and Investment Policy

The Fund is actively managed and invests in shares and convertible securities (tradable debt which can be converted into shares) issued by small to medium sized companies based in the US and traded on stock exchanges in the US or in other developed countries.

The investment manager has discretion to select the companies it chooses to invest in but does take into consideration the universe of companies represented by the Russell 2500 Index (Net Return). While the Index may inform the selection of

potential investments, the overall Fund investments, as well as the performance of the Fund, can differ significantly from the Index.


