To that end the fund will employ techniques not only taking advantage of the rise of stocks listed in regulated markets but also their decline ("long/short strategies").


Investment policy

- The fund may invest in complex instruments (financial derivative such as "futures", "options" and "swaps") to achieve its objective.
- The fund is actively managed. It seeks to outperform the US biotechnology and health care industries and adjacent industries as agricultural or crop nutrients.

Other information

- This fund will not distribute dividends. Any income generated will be reinvested in the fund.
- This subfund may not be appropriate for investors who plan to withdraw their money within 3 years.
- Investment in this fund is suitable for investors seeking stable income with moderate level of risk.


