(ISIN:IE0033281415) Man GLG Global Equity (the 'Fund') is a sub-fund of Man Funds plc (the 'Company').

Man Asset Management (Ireland) Limited, part of Man Group plc, is the Manager of the Company.

Objectives and investment policy

- The Fund seeks long term gains by investing primarily in listed or traded shares (or related instruments) of issuers in OECD markets. It may also invest in other asset classes, including debt securities, currencies, deposits and other funds and in other regions.
- Not more than 15% of the Fund's assets will be listed or traded in non-OECD markets or in any non-G8 country or in any debt securities rated less than A (or equivalent).
- Debt securities may be issued by any government, company or international agency and are not subject to a minimum rating requirement.
- The Fund may use financial derivative instruments (instruments whose price are dependent on one or more underlying assets, 'FDI') extensively to achieve the investment objective, for hedging anticipated movements in a market or a security, or where it is more economically effective than directly holding the underlying asset. The Fund is not expected to have an increased market exposure (leverage) as a result of such investments.
- The Fund may actively use FDI to provide investors with the currency risk associated with the underlying investments of the Fund, or of an appropriate benchmark.
- Any income earned on investments will be added to the value of investors' shares and investors can buy and sell their shares on each dealing day of the Fund.

Risk and reward profile
