



Sales growth is the increase in sales over a specific period of time, often but not necessarily annually. **Sharpe ratio** is a risk-adjusted measure calculated as the ratio of excess return to standard deviation. The Sharpe ratio determines reward per unit of risk. The higher the Sharpe ratio, the better the historical risk-adjusted performance. **Tracking error** is the standard deviation of the difference between the returns of an investment and its benchmark. Upside/downside market capture measures annualized performance in up/down markets relative to the market benchmark. Volatility (Standard deviation) measures how widely individual performance returns, within a performance series, are dispersed from the average or mean value. Weighted average market capitalization is an average of the market capitalization of stocks comprising a portfolio or index, adjusted by each stock's weight in
