Objectives and Investment Policy

The aim is to provide a reasonable level of income, together with the prospect of increasing the value of your investment and the income earned within the Fund, by investing in companies throughout the world.

The Fund is actively managed and invests in shares and convertible securities (tradable debt which can be converted into shares) issued by companies globally, across a range of industries. For the most part, the Fund will invest in companies based in and traded on stock exchanges in developed countries.

The investment manager has discretion to select the companies it chooses to invest in but does take into consideration the universe of companies represented by the MSCI World Index (Net Return).

While the Index may inform the selection of potential investments, the overall Fund investments, as well as the performance of the Fund, can differ significantly from the Index.


