### Objectives and Investment Policy

The aim is to increase the value of your investment over the long-term by investing in small to medium sized US companies.

The Fund is actively managed and invests in shares and convertible securities (tradable debt which can be converted into shares) issued by small to medium sized companies based in the US and traded on stock exchanges in the US or in other developed countries.

The investment manager has discretion to select the companies it chooses to invest in but does take into consideration the universe of companies represented by the Russell 2500 Index (Net Return).

While the Index may inform the selection of potential investments, the overall Fund investments, as well as the performance of the Fund, can differ significantly from the Index.

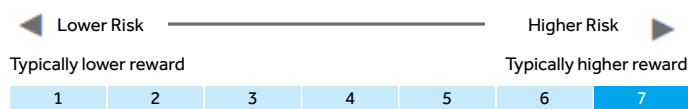
The Fund may use financial contracts (derivatives) to help achieve its aim and to manage risk, reduce costs and improve results.

Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

Income is not paid out and is rolled up (accumulated) into the value of your investment.

You may buy and sell your investment on each business day.

### Risk and Reward Profile

The following risks are materially relevant to the Fund:

The Fund may be exposed to stock market movements in a single country or region which may be adversely affected by political or economic developments, government action or natural events that do not affect a fund investing in broader markets.

The Fund may use derivatives in an attempt to reduce risk (hedging) or for investment purposes. It may be that the use of derivatives causes share prices to fluctuate which may in turn result in loss to the Fund.

The assets in which the Fund invests may be denominated in currencies other than the Fund's base currency. Changes in currency exchange rates can therefore affect the value of your investment.

Your shares will be hedged with the aim of reducing the effect of exchange rate fluctuations between their denominated currency and the base currency of the Fund. This may not completely eliminate currency risk and therefore any residual risk may affect the performance of your shares.

The Fund relies upon the performance of one or more investment managers. If the investment managers perform poorly, the value of your investment is likely to be adversely affected.

Future legal or regulatory change could have a substantial adverse effect on the Fund and your investment.

Stock markets can be volatile, meaning that the prices of shares held by the Fund can change quickly and substantially.

The Fund is not guaranteed and your investment is at risk. You may lose some or all of your investment.

The Fund may invest in smaller companies. This carries a higher risk, as the share prices of smaller companies may fluctuate more than those of larger companies and investments in smaller companies may be more difficult to sell at reasonable prices. 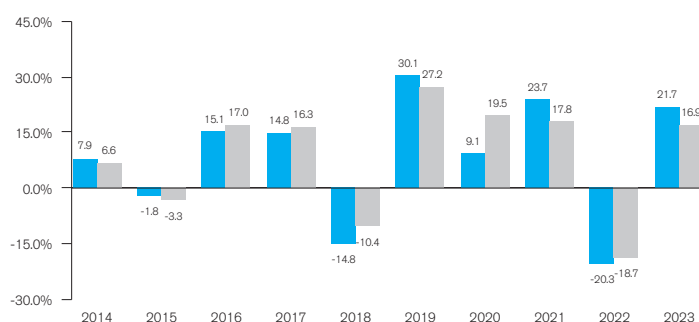
