Objectives & Investment Policy

The aim is to increase the value of your investment over the long-term by investing mainly in US companies.

The Fund is actively managed and invests in shares and convertible securities (tradable debt which can be converted into shares) issued by companies, across a range of industries, based in the US. The Fund has a bias towards large US companies and focuses on investing in shares which it believes are worth more than their sale price.

The Fund may use financial contracts (derivatives) to help achieve its aim and to manage risk, reduce costs and improve results.

Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

Income is paid out quarterly.

You may sell your investment on a daily basis.


