The objective of the Sub-Fund is to seek to generate a high level of income by investing in European corporate bonds and bonds issued by European governments.

Investment Policy

The Sub-Fund is actively managed in order to capture opportunities presented by investing in European corporate bonds and bonds issued by European governments. The following investment decisions are taken after comprehensive macroeconomic and microeconomic analysis of the market: - issuer selection

- sector allocation

- credit curve positioning (the credit curve illustrates the relationship between the investment term and the credit yield)

The Sub-Fund invests mainly in high yield fixed or floating rate bonds issued by public or private companies denominated in European currencies. Such high yielding bonds have a rating lower than BBB (according to Standard & Poor's or equivalent rating by Moody's or other rating agency).

The selection of credit instruments is not exclusively and mechanically based on their publicly available credit ratings but also on an internal credit or market risk analysis. The decision to buy or sell assets is also based on other analysis criteria of the Investment Manager.

The Sub-Fund may invest up to 10% of net assets in contingent convertible bonds (CoCos).

Within a limit of 200% of the Sub-Fund's net assets, the investment strategy may be achieved by direct investments and/or through derivatives and in particular by entering into Credit Default Swaps. Derivatives may also be used for hedging purposes.


