#### **FUND AIM**

Man GLG European Equity Alternative aims to provide positive returns primarily through shares and related instruments in issuers in Europe and of issuers which derive a substantial part of their revenues from Europe. It may also invest in issuers and markets outside Europe, and in other asset classes.

It adopts a diversified, 'long-short strategy' whereby it will use financial derivative instruments (ie instruments whose prices are dependent on one or more underlying assets,) to achieve its investment objectives or to take 'short' positions.





#### GLOSSARY

An annualised total return is an average amount of money earned by an investment each year over a given time period. It is calculated to show Annualised Return what an investor would earn over a period of time if the annual return was compounded. Volatility is the rate and extent at which the price of a portfolio, security or index, moves up and down. If the price swings up and down with large movements, it has high volatility. If the price moves more slowly and to a lesser extent, it has lower volatility. It is used as a measure of the riskiness Annualised Volatility of an investment. Annualised volatility is an average annual amount of volatility over a given time period. The current risk usage of the VaR allocation shows the actual % of risk used by each book. If the usage bar is above the allocation bar, that particular book is currently using more of its risk allowance than it normally does over the long term. If the usage bar is within the allocation bar the book is currently using less of its risk allowance than it normally does over the long term. **Current Risk Usage** The entry charge shown is a maximum figure and in some cases you might pay less. Sharpe Ratio Fund managers use this technique to borrow a security and then sell it with the intention of buying it back for less when the price falls. The position profits if the security falls in value. Within UCITS funds, derivatives – such as contracts for difference (CFDs) – can be used to simulate a short Short Position position. Synthetic Risk & Reward Featured on the Key Investor Information Document (KIID), the SRRI is a measure of the overall risk and reward profile of a fund. Funds are Indicator (SRRI) categorised on a scale from 1 to 7 where 1 is the lowest risk and 7 is the highest. Typically, the SRRI is derived from the volatility of past returns over a 5-year period. Investors should be aware the indicator is based on historical data and may not be a reliable indication of the future risk profile of the Fund. The lowest category does not mean risk free. A statistical measure of the level of financial risk within an investment portfolio. It estimates how much an investment portfolio might lose, given normal market conditions, in a set time period. As an example, for a book that has a 1% expected daily VaR we would not expect a daily loss of more than 1% in any 50 day period but there may be outlier events that cause a loss of more than this amount. Value at Risk (VaR) Within the Man GLG European Equity Alternative book structure, the VaR allocation shows the capital allocated to each book manager after adjusting for risk. It is calculated by multiplying the book capital by the expected risk usage %, which is determined as a percentage of the total capital at risk.
