Objectives and Investment Policy

- The aim is to provide capital growth and income on your investment over time.
- The Fund will normally invest at least 90% of its assets in equity securities (i.e. shares) of companies of any size that are based in or which carry out most of their business in emerging markets.
- Investments in Chinese equities include China A-shares and China B-shares with a maximum exposure of 40% of the Fund's assets. The fund may invest up to 30% of its assets in China Ashares through the Shanghai-Hong Kong Stock Connect and/or the Shenzhen-Hong Kong Stock Connect and have up to 30% of its assets exposed to China A-shares indirectly through China Ashares Access Products ("CAAP").
- The investment process identifies companies according to their economic scale. The chosen measure of economic scale is a company's contribution to Gross National Product ("GNP"). This is also referred to as "Value Added" - the difference between a company's outputs and inputs.
- The Fund may invest up to 10% of its assets in real estate investment trusts ("REITs").

- The Fund may invest up to 10% of its assets in other funds, including other funds of HSBC.
- The Fund may use derivatives for hedging or cash flow management purposes.
- The reference currency of the Fund is USD. The reference currency of this share class is USD.
- The Fund is actively managed and does not track a benchmark. Consideration may be given to a reference benchmark when selecting investments. The reference benchmark for the Fund is MSCI Emerging Markets Net.
- · Income is reinvested.
- You may sell your investment on most working days.
- Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.


