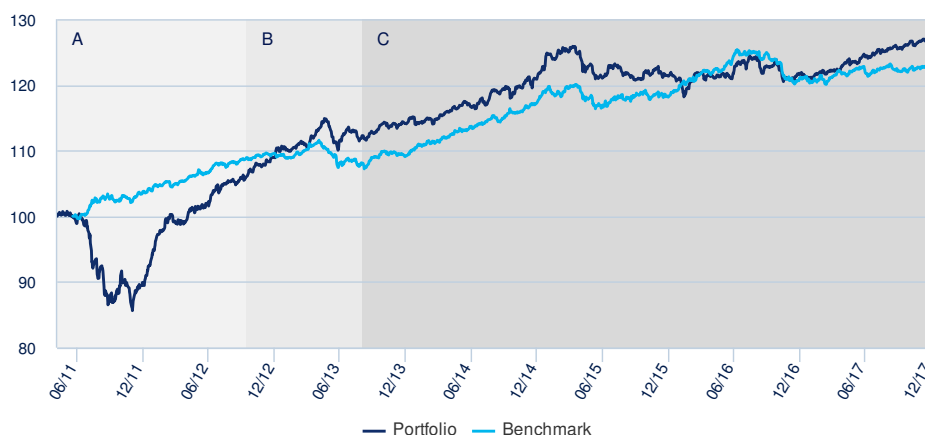

## Investment Objective

The objective of the Sub-Fund is to outperform the reference indicator Barclays Global Aggregate index (hedged in USD) through strategic and tactical positions as well as arbitrages on the whole of the credit, interest rates and currency markets. To achieve that objective, the Sub-Fund invests at least two thirds of its assets in debt instruments issued or guaranteed by governments of countries of the Organisation for Economic Cooperation and Development (OECD) or issued by corporate entities and financial instruments whose value and income payments are derived from and collateralized (or 'backed') by a specified pool of underlying asset ("asset-backed securities" and 'mortgage-backed securities') up to a maximum of 40% of its assets. The securities having a relatively low risk of default ("investment grade") represents at least 80% of the Sub-Fund's assets.

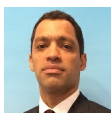

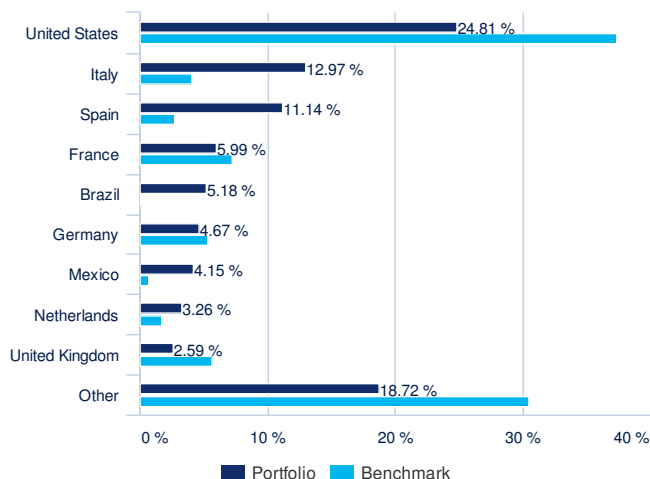
## Management commentary

December was a relatively quiet month as the European and US markets prepared for the holiday season and year end period as such, market activities were relatively muted. In December, the US Federal Reserve revealed the minutes of their December FOMC meeting, during which they hiked by another 25 bps, moving the target rate to 1.25% to 1.5% from between 1.0% and 1.25%, the bank cited continuing improvements in the labour market and a general recovery to economic activities following the disruption caused by hurricanes. In Europe, shortly after the Fed announcement, the European Central Bank (ECB) revealed their own monetary policy decision, which as widely expected, was to leave the main refinancing rates unchanged, the ECB also confirmed that from January 2018, the size of the bond purchases would be reduced to €30bn per month, from the current level of €60bn per month. In non-central bank news, on the 22nd of December, president Trump signed the "Tax Cuts and Jobs Act" into law. The new tax bill cuts corporate taxes and provides individuals with temporary tax relief, the new bill also removes the individual contribution that was a requirement under the Affordable Care Act – which could see health insurance premiums rise. In south Africa, President Zuma survived a motion to impeach him for potential misuse of public funds after the high court ruled that parliament had failed to hold the president accountable. Most currencies rose against the dollar in December despite the tax cuts as markets corrected.

The fund and benchmark returns were positive, with the fund marginally outperforming. A number of developed markets government bond yields rose, so that our underweight duration exposure benefited. Relative returns were helped by our yield curve flattening positions as curves continued to flatten and overweight exposure to credit also helped. Within currencies, inter- and intra-bloc currency allocations were positive, with overweight allocations to the EUR vs other major currencies and in particular, the GBP helped significantly, as did a preference for the KRW over the JPY. Emerging markets currencies detracted from returns.

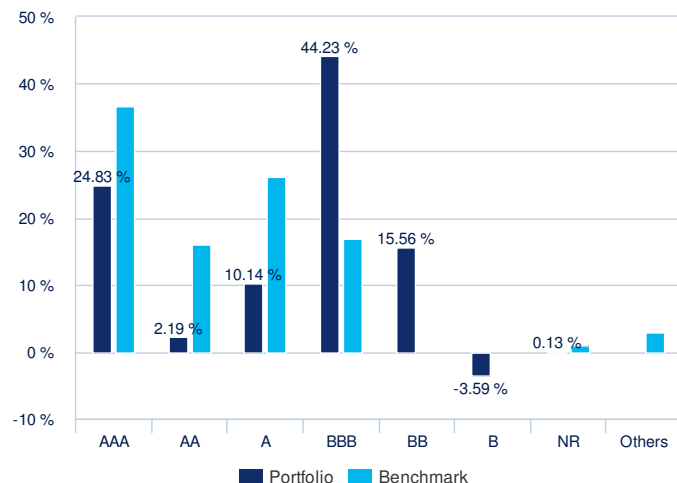
