
Objectives and Investment Policy

The Fund seeks to increase the value of its assets over the medium term by investing in shares issued by Indonesian companies, or companies operating in this country.

It is actively managed and as such may invest in securities that are not included in the index which is Jakarta SE Composite (PI). Income are systematically reinvested.

Investors are able to redeem on a daily basis (on Luxembourg bank business days).

Risk and Reward Profile


