Objectives and investment policy

The Fund seeks to increase the value of its assets over the medium term by investing in shares issued by German companies.

The investment process emphasizes a research-driven quantitative process coupled with a bottom up stock selection approach, whereby the stocks are selected based on four factors - low volatility, value, profitability and momentum.

Although the majority of the Fund equity securities may be components of the index MSCI Germany (EUR) RI (the «benchmark»), the Investment Manager uses its wide discretion in relation to the benchmark to invest in companies and sectors not included in the benchmark in order to take advantage of specific investment opportunities.


The Investment Manager applies also BNP PARIBAS ASSET MANAGEMENT's Sustainable Investment Policy, which takes into account Environmental, Social and Governance (ESG) criteria in the investments of the Fund. In addition to the performance research, the portfolio is built in order to improve its ESG score and to reduce its carbon footprint.

Internal investment guidelines have been defined, including in reference to the benchmark, and are regularly monitored to ensure the investment strategy remains actively managed, while maximizing the strategy's diversification and risk-adjusted return potential. Nevertheless, due to similar geographical constraint and limited size of the investment universe (approximately 60 stocks), investors should be aware that the Fund's risk and return profile may, from time to time, be comparable to the risk and return profile of the benchmark.

Environmental, social and governance (ESG) criteria contribute to, but are not a determining factor in, the manager's decision making. Incomes are systematically reinvested.

Investors are able to redeem on a daily basis (on Luxembourg bank business days) as described in the prospectus

Risk and reward profile


