Objectives and Investment Policy

The Fund seeks to increase the value of its assets over the medium term by investing in shares issued by US companies or companies operating in the USA, which distribute dividends higher than the average in such markets.

It is actively managed and as such may invest in securities that are not included in the index which is S&P 500 Composite (Hedged in EUR) (RI). A dividend may be distributed.

Investors are able to redeem on a daily basis (on Luxembourg bank business days).

This share class aims at hedging its currency exchange risk against the Fund's portfolio exposure currency. However, the currency exchange risk cannot be completely neutralized as the hedging technique is based of the Fund's NAV.

The risk category is justified by the investment mainly in Stocks and Shares, the value of which can fluctuate considerably. These fluctuations are often amplified in the short term.







