### Objectives and Investment Policy


The Fund seeks to increase the value of its assets over the medium term by investing in shares issued by companies operating in the utilities sector and/or in related sectors.

It is actively managed and as such may invest in securities that are not included in the index which is MSCI World Utilities (NR).

Income are systematically reinvested.

Investors are able to redeem on a daily basis (on Luxembourg bank business days)

- <u>Liquidity Risk:</u> This risk arises from the difficulty of selling an asset at a fair market price and at a desired time due to lack of buyers.
  - Operational and Custody Risk: Some markets are less regulated than most of the international markets; hence, the services related to custody and liquidation for the subfund on such markets could be more risky.


