Objectives and investment policy

This Fund is actively managed. The benchmark Bloomberg Barclays Global Aggregate (hedged in EUR) RI is used for performance comparison only. The Fund is not benchmark constrained and its performance may deviate significantly from that of the benchmark. The Fund seeks to increase the value of its assets over the medium term by investing in investment grade bonds and/or other debt instruments, denominated in various currencies and issued by companies all over the world. The Fund will use different strategies in the portfolio to ensure diversification and flexibility. The weighting of the different strategies may vary over time according to the evolution of market conditions and to reflect the anticipations of the investment team.

The Fund may invest up to 100% of its assets in structured debt instruments.


After hedging, the exposure to currencies other than EUR may not exceed 20% The sub-fund may be invested into debt securities traded on the China Interbank Bond market.

- Why is the Fund in this specific category? The risk category is justified by the investment mainly in Interest Rate instruments. The investor's attention is drawn to the fact that an increase
- in interest rates results in a decrease in the value of investments in bonds and debt instruments and more generally fixed income instruments. • The higher the risk, the longer the recommended investment horizon.

Other risks materially relevant to the Fund which are not adequately captured by the indicator are described below:

- Credit Risk: This risk relates to the ability of an issuer to honour its commitments: downgrades of an issue or issuer rating may lead to a drop in the value of associated bonds
- Liquidity Risk: This risk arises from the difficulty of selling an asset at a fair market price and at a desired time due to lack of buyers.
- Counterparty Risk: This risk is associated with the ability of a counterparty in an Over The Counter financial transaction to fulfil its commitments like payment, delivery and reimbursement.
- Operational and Custody Risk: Some markets are less regulated than most of the international markets; hence, the services related to custody and liquidation for the subfund on such markets could be more risky.
- Derivatives Risk: When investing in over the counter or listed derivatives, the Fund aims to hedge and/or to leverage the yield of its position. The attention of the investor is drawn to the fact that leverage increases the volatility of the subfund
- Risk related to investments in Mainland China: such investments are subject to additional risks that may be the result of political, economic, social, tax, market and operational factors specific to the Chinese Market.


