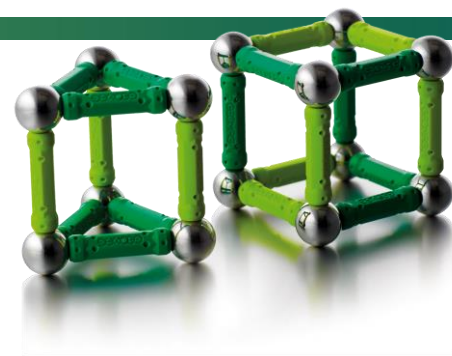

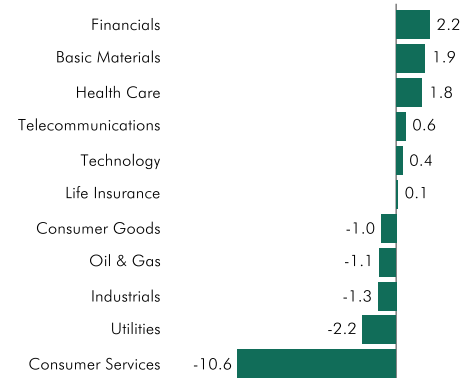

RISK FACTORS

Geographic Concentration Risk - a rise or fall in the UK market may have a significant impact on the value of the Fund because it primarily invests in this market.
