Objectives and investment policy

The objective is to obtain positive risk-adjusted returns under any market circumstances (bull or bear markets).

The annual return target is set at 7-10%, with an average annual volatility target of around 4-7%, bearing in mind that there is neither a guaranteed maximum annual loss nor a guaranteed minimum annual return.

The sub-fund may invest, without there being any predetermined allocation, by taking long and short positions in global equities, fixed income, foreign exchange and commodities.

The long positions may be held through a combination of direct investments and/or financial derivative instruments. Except for commodities, for which only financial derivative instruments may be held and the short positions will be held through the use of financial derivative instruments.

The exposure to commodities may represent 10% of the net assets.

The weight of short positions could range from 0 to 100.

The investments will be centered on securities and financial instruments with high liquidity.

The sub-fund may use currency forwards and futures for hedging purposes or to gain exposure to other currencies.

The sub-fund may not invest more than 10% of its assets in other UCITS and other UCIs.


The risk measurement model used will be absolute Value at Risk (VaR), with a time horizon of one day and a confidence level of 99%. The absolute Value-at-Risk of the portfolio will be computed daily. The maximum monthly VaR shall not exceed the limit of 20% of the total net assets of the relevant sub-fund. The maximum daily VaR limit will be 4.47% of the assets.

Recommendation: this sub-fund may not be appropriate for investors who plan to withdraw their money within 3-5 years.

Shareholders may redeem shares on demand, on each Business Day. Non-distribution shares: any income generated by the sub-fund is reinvested.

Please note that transaction costs may have material impact on performance.

The sub-fund is subject to the following risks:

Credit risk: the sub-fund invests in securities which are exposed to the risk that the issuer will be unable to meet its repayment obligations. The credit rating and risks associated with such securities can change over time and therefore affect the performance of the investments.

Equity risk: the value of equities and equity-related securities can be affected by daily stock market movements.

Use of derivatives: derivatives are used for investment purposes and contribute to obtain, increase or reduce exposure to underlying assets.

Currency risk: the risk that an investment's value will be affected by changes in exchange rates.


The **entry charge** shown is a maximum figure. In some cases you might pay less; you can find this out from your sales agent or financial advisor.
