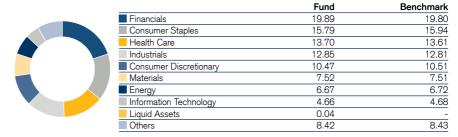
Net performance in EUR (rebased to 100) and yearly performance 2)



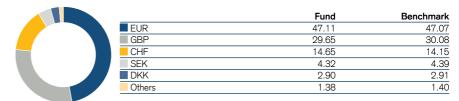
