#### **Objectives and Investment Policy**


#### Objective

The Fund's aim is long term capital appreciation through investing predominantly in equity and equity-related securities on a worldwide basis. Investment Policy

The Fund invests predominantly in equity and equity-related securities on a worldwide basis. The Fund may invest up to 35% of its Net Asset Value ("NAV") in debt and debt-related securities (such as notes, preferred securities, debentures, fixed or floating rate bonds) issued by Governments, municipalities, agencies, supranationals or corporates listed or traded on one or more Recognised Exchanges worldwide with a rating at least A2\P2 from Standard & Poors/ Moodys, respectively. The Fund may also invest up to 5% of its NAV in UCITS and non-UCITS. The Fund may hold up to 30% of its NAV in cash deposits and/or cash equivalents; in exceptional market conditions, such cash deposit and/or cash equivalents may be up to 50% of the NAV. Essential features of the Fund:

- The Fund has the discretion to invest in a range of investments as described above.
- Derivatives are used for efficient portfolio management and to protect the fund against exchanges risk.
- You can buy and sell shares in the Fund on each business day.
- This Fund may not be appropriate for investors who plan to withdraw their money within 5 years.
- Income from the Fund will be added to the value of your investment.
- The Fund's performance is measured against the MSCI Daily TR Net World USD.

#### **Risk and Reward Profile**



- This indicator shows how much a Fund has risen and fallen in the past, and therefore how much a Fund's returns have varied. It is a measure of a Fund's volatility. As the share class has less than 5 years price history, this calculation incorporates the volatility of the Fund's representative portfolio model, target asset mix or benchmark. The higher a Fund's past volatility the higher the number on the scale and the greater the risk that investors in that Fund may have made losses as well as gains. The lowest number on the scale does not mean that a Fund is risk free.
- The Fund has been classed as 5 because its volatility has been measured as medium.
- This indicator is based on historical data and may not be a reliable indication of the future risk profile of this Fund. The risk and reward profile shown is not guaranteed to remain the same and may shift over time. Investors may not get back the amount originally invested and may lose money.

- Liquidity Risk: At times, some shares may trade infrequently which means it may be more difficult for the Fund to buy and sell them. Prices may also be subject to short term swings.

Fixed Income Security Risk: Fixed interest securities are affected by trends in interest rates and inflation. If interest rates go up the value of

- Currency Risk: At the portfolio level any currency hedging decisions with regards to non-base currency exposures are at the Fund manager's discretion. When the Fund is not hedged, as the Fund invests in overseas securities, any movements in exchange rates may cause the value of your investment to increase or decrease. At the share class level, this is a non base currency share class which is not hedged back to the base currency of the Fund and may cause the value of your investment to increase or decrease.
- Custody risk: there may be a risk of a loss where the assets of the Fund are held in custody that could result from insolvency, negligence or fraudulent action of the custodian or sub-custodian.
- Financial Techniques Impact: The Fund may invest in derivatives, which may cause the Fund to be leveraged, i.e. the Fund's exposure is greater than its net asset value. A relatively small movement in the value of the derivative's underlying investment may have a much larger impact, positive or negative, on the value of the Fund than if the Fund were to hold the underlying investment itself.
