






Geographical breakdown (%)




Overall Impact On: People





Overall Impact On: Planet



Schroder ISF Strategic Credit was launched on 12.03.2014 to accommodate a transfer of shareholders from the Cazenove fund to the Schroder ISF SICAV Please note that the fund's benchmarks were changed on 21 June 2021. The past performance in the above table is based on the fund's objective and benchmarks (Target benchmark: GBP 3 Month LIBOR. No comparator benchmark) in place prior to this date.
