Objectives and Investment Policy

The Fund aims to increase the value of your investment over the long term by mainly investing in (i) shares of companies in Mexico; (ii) shares of companies, from any country, which carry out most of their business in Mexico; and (iii) other financial instruments which provide exposure to these shares.

The Fund may also hold cash, debts issued by companies, governments or other entities and in investments which can be easily converted into cash, such as Treasury Bills and money market funds. On a secondary basis, the Fund may also invest in shares of Latin American companies.

The Fund seeks to outperform the MSCI Mexico 10/40 net index by selecting the shares of companies that the Investment Manager believes will provide the best returns.

Please note that transaction costs may have material impact on performance.

Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

Fund income (dividends) will not be paid out, but instead will be reinvested.

You may buy and sell your shares in the Fund on demand on any Luxembourg and Mexico City business day on 1 business day notice.

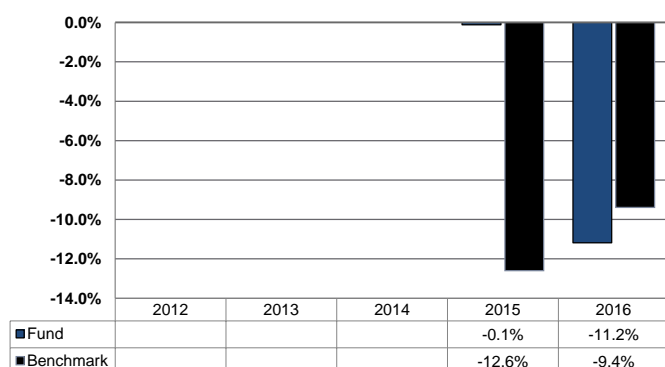
