### **Objectives and investment policy**

The objective of the Fund is to provide you with an exposure to the Merrill Lynch Commodity Index eXtra 3XG.

The Index is intended to reflect the performance of commodities from the following sectors: energy, precious metals and base metals.

The Index commodities are represented by futures contracts (i.e. contracts to buy or sell commodities at a fixed price in the future). Each contract is replaced by a new contract before its expiry.

Target weights for each Index commodity are determined annually and reset on a monthly basis.

To achieve its objective, the Fund will:

 $\mbox{-}$  enter into a total return swap with a counterparty to gain for exposure to the Index.

 - enter into one or more 'cash management' transactions such as a reverse repurchase agreement (under which the Fund will buy securities from a counterparty, such as Merrill Lynch International, with an agreement to sell back such securities at a future date), or the purchase of a portfolio of transferable securities and/or collective investment undertakings, to generate interest rate flows; and

# The currency of the Fund is the USD and your shares will be denominated in USD.

Your shares are non-distributing (i.e. any income arising from your shares will be included in their value).

You may redeem your shares on demand on any UK, US and Luxembourg banking day.




