#### **Objectives and Investment Policy**

The Fund seeks to increase the value of its assets over the medium term by investing in shares undervalued as compared to the market on the purchase date, issued by US companies, and/or companies operating in this country.

It is actively managed and as such may invest in securities that are not included in the index which is Russell 1000 Value (hedged in EUR) (RI).

A dividend may be distributed.

Investors are able to redeem on a daily basis (on Luxembourg bank business days).

This share class aims at hedging its currency exchange risk against the Fund's portfolio exposure currency. However, the currency exchange risk cannot be completely neutralized as the hedging technique is based of the Fund's NAV.


#### Charges
