#### Objectives and investment policy

This Fund is actively managed. The benchmark Bloomberg Euro Aggregate Corporate 1-3 Years is used for performance comparison only. The Fund is not benchmark constrained and its performance may deviate significantly from that of the benchmark.


The Fund seeks to increase the value of its assets over the medium term by investing in investment grade bonds and/or other debt instruments denominated in EUR and issued by European companies or companies operating in Europe and in derivatives on this type of asset. Credit or interest rate derivatives may be used for hedging and/or trading purposes. The sub-fund will run an average maturity that does not exceed 3.5 years.

The investment team applies also BNP PARIBAS ASSET MANAGEMENT Sustainable Investment Policy, which takes into account Environmental, Social and Governance (ESG) criteria at each step of the investment process of the Fund. An extra-financial strategy may comprise methodological limitations such as the ESG Investment Risk as defined by the asset manager. Environmental, social and governance (ESG) criteria contribute to, but are not a determining factor in, the manager's decision making.

A dividend may be distributed.

Investors are able to redeem on a daily basis (on Luxembourg bank business days) as described in the prospectus.

### Risk and reward profile

- Liquidity Risk: This risk arises from the difficulty of selling an asset at a fair market price and at a desired time due to lack of buyers.
- Operational and Custody Risk: Some markets are less regulated than most of the international markets; hence, the services related to custody and liquidation for the subfund on such markets could be more risky.
