Objective and Investment Policy

Investment Objective

The Sub-Fund's investment objective is to seek performance by investing mainly in inflation-linked bonds in Euros, over a medium term period.

Investment Policy

The Sub-Fund is actively managed in order to capture opportunities in the Euro inflation-linked bond market. The following investment decisions are undertaken after comprehensive macroeconomic and microeconomic analysis of the market:

- positioning on the inflation-linked yield curve (the inflation-linked yield curve illustrates the relationship between the investment term and the inflation linked bond yield)
- management of duration for inflation linked-bonds (duration measures in numbers of years the portfolio's sensitivity to interest rate variations)
- positioning according to inflation expectations
- geographical allocation

- The Sub-Fund invests:
 at least two thirds of its total assets in inflation-linked bonds and other related debt securities issued by governments, corporations or public institutions of the Eurozone and denominated in Euro
- up to one third of its total assets in non inflation-linked debt securities and in money market instrument

This Sub-Fund will invest at least 90% of its net assets in investment grade debt securities.

Investment grade securities will be rated at least BBB- by Standard & Poor's or equivalent rating by Moody's or Fitch or if unrated then deemed to be so by the Investment Manager. Sub-investment grade securities will be rated between BB+ and B- by Standard & Poor's or equivalent rating by Moody's or Fitch or if unrated then deemed to be so by the Investment Manager. In case of downgrade below B- by Standard & Poor's or equivalent rating by Moody's or Fitch or if unrated then deemed to be so by the Investment Manager, securities will be sold within 6 months. If two different ratings of rating agencies exist, the lower rating will be considered, if more than two different ratings of rating agencies exist, the second highest rating will be

The selection of credit instruments is not exclusively and mechanically based on their publicly available credit ratings but also on a internal credit or market risk analysis. The decision to buy or sell assets is also based on other analysis criteria of the Investment Manager.

The Sub-Fund applies AXA IM Environmental, Social and Governance (ESG) Standards available on www.axa-im.com/en/responsible-investing.

The Sub-Fund may invest up to 5% of net assets in contingent convertible bonds (CoCos).

Within the limit of 200% of the Sub-Fund's net assets, the investment strategy may be achieved by direct investments and/or through derivatives, especially by entering into Credit Default Swaps. Derivatives may also be used for hedging purposes.

The Sub-Fund targets a sensitivity between 5 and 15. If interest rates increase by 1%, the Net Asset Value of the Sub-Fund may decrease by 5% up to 15%.

For Distribution share classes (Dis), the dividend is distributed.

The reference currency of the Sub-Fund is EUR.




