Objectives and Investment Policy

The Fund is a feeder fund of the Luxembourg master fund PARWORLD Quant Equity World Guru (the «Master Fund»). The Fund seeks to increase the value of its assets over the medium term by investing at least 85% of its assets in the Master Fund which implements a quantitative stock picking of worldwide equities, either indirectly (through the use of index derivatives) or directly. The Master Fund invests in shares issued by companies of any country and may use derivatives such as performance swaps.

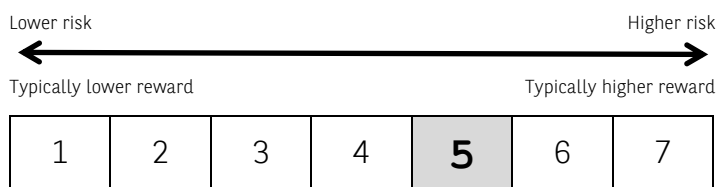
The Master Fund is actively managed and as such may invest in securities that are not included in the benchmark which is MSCI AC World (NR).

The Fund and Master Fund performance may differ due to ancillary assets held by the Fund, and potential discrepancies in operating expenses across both structures.

Income are systematically reinvested.

Investors are able to redeem on a daily basis (on Luxembourg bank business days) unless the net asset value of the Master are not calculated.

Risk and Reward Profile

- Why is the Fund in this specific category?
The risk category is justified by the performance of the fund's Master's strategy's index that can vary strongly up or down, involving potential quick and strong changes in the investment's value.
- The higher the risk, the longer the recommended investment horizon.

Other risks materially relevant to the Fund which are not adequately captured by the indicator are described below:

- **Liquidity Risk:** This risk arises from the difficulty of selling an asset at a fair market price and at a desired time due to lack of buyers.
- **Counterparty Risk:** This risk is associated with the ability of a counterparty in an Over The Counter financial transaction to fulfil its commitments like payment, delivery and reimbursement.
- **Operational and Custody Risk:** Some markets are less regulated than most of the international markets; hence, the services related to custody and liquidation for the subfund on such markets could be more risky.
- **Derivatives Risk:** When investing in over the counter or listed derivatives, the Fund aims to hedge and/or to leverage the yield of its position. The attention of the investor is drawn to the fact that leverage increases the volatility of the subfund.

In order to be processed at a specific net asset value, requests for subscriptions, conversions and redemptions must be received by local agents or distributors or directly by the transfer agent before 16:00 CET (for STP orders) or 12:00 CET (for non STP orders) in Luxembourg on the day preceding the valuation day. Subscriptions in kind are not authorised.

In order to be processed at a specific net asset value, requests for subscriptions, conversions and redemptions of the Master Fund must be received by local agents or distributors or directly by the transfer agent of the Master Fund before 16:00 CET (for STP orders) or 12:00 CET (for non STP orders) in Luxembourg on the valuation day. Payment take place within three trading days of the valuation day.

Charges

The charges you pay are used to pay the Fund's running costs, including the costs of marketing and distribution. These charges reduce the potential growth of your investment.

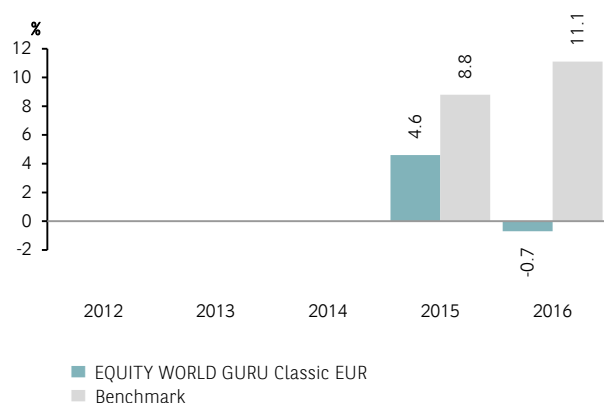
This figure may vary from year to year. It excludes:
